The Alabama Board of Examiners in Psychology seeks to promote and protect the public's health, welfare and quality of life by licensing and regulating the practice of psychology and by promoting access to psychological services delivered in a safe, competent, and ethical manner.

### **REVIEW OF MINUTES:**

Review of the Minutes from the November 20, 2020 meeting. Motion by Belle: I make a motion that we accept the Minutes from the November meeting. Seconded by Berland. Motion passed. Cook abstained. Arata granted Rall permission to sign the official Minutes in her place.

#### **REVIEW OF NEW APPLICANTS:**

### **Psychologists**

- 1) ARMSTRONG, Amanda Kay EPPP and PSE Candidate (Ackerson and Belle) Motion by Ackerson: I would move that we vote to admit Dr. Armstrong to the EPPP and the PSE. Seconded by Belle. Motion passed.

- 5) COOK, Roy Rodney PSE Candidate (Cook and Ackerson) Motion by Cook: I move that we issue a Cease and Desist Order to Applicant Roy Rodney Cook related to the work he is performing as a self employed contractor and consulting psychologist at and with the Central Alabama Veterans Health Care System, as it appears he is in violation of Ala. Code Section 34-26-46(a)(21) and the Board's Administrative Code Rule 750-X-5-.03(1)(t), and that we admit Dr. Cook to the Professional Standards Exam, and that we issue a private letter of reprimand to him, copying supervisor Dr. Jenniffer LaPoint MD at CAVHS, for inadvertently engaging in the unlicensed practice of psychology rather than taking formal disciplinary action against his license, if and when it is issued by the Board after his successful passage of the PSE. Seconded by Ackerson. Motion Passed. Bowers abstained.
- 6) SELTZER, Jed Daniel EPPP and PSE Candidate (Belle and Miller) Motion by Belle: I move that we admit Dr. Seltzer to the EPPP and PSE. Seconded by Miller. Motion Passed.

### **Psychological Technician**

1) MOON, Kadija Karae Joera – EPPP and PSE Candidate (Miller and Belle) Motion by Miller: I make a motion that we admit Ms. Moon to the EPPP and PSE. Seconded by Belle. Motion passed.

- BORKOSKY, Bruce Glenn PSE Candidate (Ackerson and Belle) Application reviewed on 05/10/2019; admitted to PSE, requested revised Specialization statement and additional professional references from supervisors from his post-doctoral training. Review. (Passed PSE on 11/25/2020; review for licensure) Motion by Ackerson: I make a motion that we table this application and seek further information from Dr. Borkosky specifically related to 1) his prior work as a forensic psychologist and whether he has engaged in the practice of the use of hypnosis for memory retrieval in order to present that in a court of law and for us to be able to get court transcripts to determine whether he engaged in that behavior and 2) whether it is a standard part of his practice that he shares testing materials to include test protocols with patients and clients that are not licensed psychologists, in violation with his contract with the test publishers. Seconded by Berland. Arata voted in favor. Belle voted in favor. Bowers voted in favor. Miller voted in favor. Cook voted not in favor of the motion. Motion passed.
- 2) CARRION, Leslie Paige EPPP and PSE Candidate (Arata) Application reviewed on 07/12/2019; admitted to exams, requested revised Specialization statement to remove neuropsychological assessments. Revision reviewed on 9/13/2019 and denied for failure to remove the neuropsychological components of the statement, to include administration and the interpretation of the D-KEFS or NEPSY-II. Review of second revision. (Passed EPPP on 11/24/2020 and PSE on 11/27/2020; review for licensure) Motion by Arata: I move that we accept her revised Specialization statement. Seconded by Belle. Motion passed.

- Vulnerable Child Compassion and Protection Act 2021 Legislative Session. Introduced as House Bill (HB) 1, Sponsored by Representatives Allen, Holmes, Pettus, Mooney and Brown, and Senate Bill (SB) 10, Sponsored by Senator Shelnutt. HB1 is assigned to the Judiciary Committee; SB10 is assigned to the Healthcare Committee. Motion by Ackerson: I make a motion that the Board takes the strongest opposition to these bills, and that we rely upon evidence and logical arguments laid out by Dr. Cook in bolstering our position in this case, and that we reach out the Alabama Association of Pediatrics, and the Alabama Psychiatric Association, the Alabama Association of Licensed Professional Counselors, and the Alabama Association of Social Workers, Marriage and Family Therapists, and our Association [Alabama Psychological Association], and the allied State Boards, and other mental healthcare or medical associations or organizations that we believe would also be impacted by these bills to join us in this effort. Seconded by Bowers. Motion passed.
- 2) ASPPB Midyear Meeting, April 9-10, 2021 Virtual Meeting Format. Will notify the Board as more information is available about registration and a call for attendance.
- Nominate and vote on Board Chair and Vice-Chair. Motion by Ackerson: I make a motion that we continue with our current leadership roles until such time as we have new appointees coming onto the Board. Seconded by Cook. Motion passed.

Motion by Arata: I move that we adjourn the meeting; the time is 12:10 pm. Seconded by Ackerson. Motion passed.
