<u>PREVIOUSLY REVIEWED APPLICANTS</u> (addressed out of order): <u>Psychologists</u>

- 2) LANE, Morgan Elise – EPPP and PSE Candidate (Cook and Belle) Application tabled on May 13, 2022. Cease and desist letters were issued to the applicant and to the applicant's employer and supervisor in private practice, Dr. Felicia Houston, Ph.D. to ensure that the applicant is not practicing psychology without a license. The Board asked Dr. Houston to explain her possible role in supervising or aiding and abetting the applicant's practicing without licensure. The Board requested clarification and documentation from applicant about how the internship experience meets qualifying criteria specified in Administrative Code Rules, a professional reference from internship experience, and modification to Specialization Statement to remove planned practice in Clinical Psychology, consistent with education and training in School Psychology. Review response(s). Mr. Johnston recommended that the Board go into Executive Session to discuss the potential threat of, or possibility of, litigation of the good name and character of an individual. Motion by Cook: I move that Board goes into Executive Session for twenty (20) minutes to discuss the potential threat of, or possibility of, litigation of the good name and character of an individual. Seconded by Belle. Motion passed. The Board moved into Executive Session at 10:44 a.m. with the intention of returning at 11:05 a.m. Motion by Cook: I move that we come out of Executive Session at 12:34 p.m. Seconded by Carlton. Motion passed. Motion by Cook: I move that we admit Dr. Lane to sit for the EPPP and PSE, and should she pass the exams, that she be issued a license. However, we will continue to investigate the matter of whether she practiced without a license from December 2021 to April 2022. If the Board determines that she practiced without a license in that time frame, then her license may be subject to disciplinary action up to and including probation and public or private reprimand with continuing education requirements, as will be finally decided once additional information is received from Dr. Houston and her counsel. Seconded by Douglas. Motion passed.
- KIRKLAND, Karl PSE Candidate (Belle and Carlton) Application tabled on May 13, 2022 for the Board to continue to review multiple documents and sources of information related to the application. Review. Mr. Johnston recommended that the Board go into Executive Session to discuss the potential threat of, or possibility of, litigation of the good

Motion by Carlton: I make a motion that the Board deny Dr. Karl Kirkland's application for licensure based on the Administrative Code Rules 750-X-5-.03(1)(c), (d), (e), (f), and (3) and also Alabama Law Section 34-26-46(a)(3) through (6), and (g). Seconded by Belle. Motion passed unanimously.

2) PHILLIPS, Jamie Turner – EPPP and PSE Candidate (Belle and Lewis) Application tabled on May 13, 2022. The Board requested more information about the work the candidate is performing and plans to perform as a school-based therapist and how that work is authorized under any section of Alabama law, a statement about the candidate's intent to practice independently and without supervision, and details on how the candidate has maintained competence in the years since earning a master's degree. Review response. Motion by Belle: I move that we issue Jamie Turner Phillips a Cease and Desist notice for practicing without a license. Seconded by Lewis. Motion passed. Motion by Belle: I move that we admit Ms. Phillips to the EPPP and PSE and, upon successful passage of the exams, the Board will take Disciplinary Action upon her license by placing it on Probation for practicing without a license, which will be a Public Action with an Administrative Fee due of \$300.00, and she will also be required to complete ten (10) hours of continuing education in the area of Ethics or Ethical Practice in addition to standard continuing education requirements, and the license will remain on Probation until such time all conditions are met. Second by Lewis. Motion passed.

<u>REVIEW of Examination for Professional Practice in Psychology (EPPP) and Professional</u> Standards Exam (PSE) Results and Licenses Issued since the last meeting of the Board on <u>May 13, 2022</u>:

- Wellness Committee Report The Committee meets on the second Fridays of evennumbered months and the Committee has an independent email address (wellness@psychology.alabama.gov). Ms. Rall provided statistical information on meetings and committee participation.
- 2) The Alabama Human Life Protection Act Act #2019-189 Directives for Psychology professionals have been requested. Review of the Act and related Administrative Code Chapter 420-5-1 Abortion or Reproductive Health Centers, subsection -.01(2)(o) defining a "Qualified Person", and -.03(4)(f) concerning Informed consent, and associated Appendix Forms, and -.03(9) concerning Mandatory Reporting. Legislation should not impact or expand a psychology professional's scope of practice, as a qualified person

describing or obtaining informed consent or impact responsibilities as mandatory reporters.

- 3) Inquiry from the Alabama Medicaid Agency's Medicaid Fraud Control Unit Request for clarification on supervision in practice, related to Medicaid Chapter 34 Providers. Dr. Belle, Ms. Lewis, Mr. Johnston, and Ms. Rall volunteered to assist Medicaid and the Attorney General's Office as might be necessary in the future.
- 4) Quarterly Report 3rd Quarter FY2022 Review
- 5) Operations Plan Fiscal Year 2023 Due by July 29, 2022 Earmarked Funds and Appropriation Total of \$558,478 from Professional Occupational Licensing and Regulation Funds, as provided in Section 34-26-43, Code of Alabama 1975, not General Fund revenue. Review.

- AGIT, Maria Application denied January 14, 2022 for failure to meet education and training requirements; denial upheld after informal reconsideration, May 13, 2022. Formal reconsideration has been requested. Hearing scheduled for Tuesday, August 9, 2022 at 10:00 a.m. One (1) Board member must attend – Dr. Belle offered to attend.
- 2) Clara Elizabeth "Beth" Long, Ph.D., LPC Review for violation(s) of ALA. CODE § 34-26-42 in November 2021, January 2022, and again in May 2022. The Board sent cease and desist instructions to Dr. Long to cease holding herself out as a Psychologist in the State of Alabama and requested a return statement from Dr. Long that she has rectified this matter and addressed any unlawful conduct within thirty (30) days of receipt of the letter, copying Dr. Larry McLemore, Head of School at the Saint James School, and Dr. Keith Cates, Executive Director of the Alabama Board of Examiners in Counseling. Review response(s).
- 3) EPPP (Part 2 Skills) Virtual Townhall Meetings were held on May 16 and May 17, 2022, and were open to all ASPPB Membership. Discussion on EPPP Part 2 Skills. Cook will share APA Division 31 information regarding EPPP Part 2 and Lori will share available Town Hall recordings.
- 4) Military Family Jobs Opportunity Act ACT #2022-92, Passed March 8, 2022 Act requires boards to adopt related rules on or before January 1, 2023. Review drafted Rule and documentation. The Board will continue its review of drafted language covering a fee waiver allowed to adhere to new military law, different forms, separate application for the next Board meeting.
