Review of the September 9, 2022 Minutes. Motion by Carlton to accept the Minutes as written. Seconded by Cook. Motion passed.

# **PUBLIC HEARING – RULES AND REGULATIONS**

Review by Cook: Amendments to Rules and Regulations: Administrative Code Rules amendment to Chapter 750-X-2-.03, <u>Application Form</u>., and Chapter 750-X-2A-.03, <u>Application Form</u>., and new Chapter 750-X-2-.10, <u>Certification of Applicants Licensed to Practice in Another</u> <u>Jurisdiction Pursuant to Alabama Military Family Jobs Opportunity Act</u>. Posted via Notice of Intended Action in the <u>Alabama Administrative Monthly</u>. Notices of Intended Action were published in the Alabama Administrative Monthly, Volume XL, Issue No. 12, September 30, 2022, and posted on the Board's website. As of November 4, 2022, the Board has not received any comments. Motion by Carlton to close the Public Hearing. Seconded by Cook. Motion passed at 9:15 a.m.

#### **PREVIOUSLY REVIEWED APPLICANTS:**

#### Psychologist(s)

1) MORALES LUCIANO, Charlyn Melanie – EPPP and PSE Candidate (Cook) Application was tabled on July 8, 2022, with Board's request for information about employment history and clarification on role as "bridge therapist." Board reviewed response at September meeting. On September 11, 2022, the Board admitted candidate to sit for the EPPP and PSE with a request for further employment history that was not completely provided, or has not yet been provided, and request for clarification on whether and how her activities at AltaPointe are consistent with Code of Alabama 34-26-42 and, if she is practicing psychology without the benefit of an Alabama license, she should cease and desist such practice. If licensed, infractions may be applied to the license based upon responses to employment history and practicing without a license. On September 11, 2022, the Board issued a Cease-and-Desist letter to AltaPointe directing them to cease and desist any aiding and abetting the unlicensed practice of psychology by Dr. Morales Luciano, consistent with the letter the Board sent the organization in July 2020. Review of applicant's response and AltaPointe's response by Cook. Cook noted that the clinical responsibilities listed seemed to be in line with the practice of a licensed psychologist; Rall noted that the employer advised the applicant is operating under the umbrella of Mental Health. Cook ended discussion on Morales Luciano to prepare for Stookey and Bressette (scheduled to speak with the Board at 10:00 a.m.).

#### **Psychological Technician**

1) STOOKEY, Emily Sims – EPPP and PSE Candidate (Lewis) Application was tabled on July 8, 2022, with Board's request for information about employment history, areas of competency, and future practice. Boarded reviewed response along with Supervision Application and Contract at September meeting. On September 11, 2022, the Board admitted candidate to sit for EPPP and PSE with a request for clarification on whether and how her activities at Spectrum Mental Wellness, LLC are consistent with Code of Alabama 34-26-42 and, if she is practicing psychology without the benefit of an Alabama license, she should cease and desist such practice and that we issue a Cease-and-Desist letter to Ms. Stookey and to Spectrum Mental Wellness, LLC directing them to cease and desist any aiding and abetting the unlicensed practice of psychology by Ms. Stookey or anyone else, and, once licensed, infractions may be applied to the license for practicing without a

license. Review response from candidate. Review response from Keri A. Bressette, Ph.D. with Spectrum Mental Wellness, LLC (both individuals scheduled to speak with the Board at 10:00 a.m.). Review of Administrative Code 750-X-5-.05 Psychologists' Accountability For Technical And Support Staff.

## Bressette and Stookey joined meeting via Zoom at 10:00 a.m.

Bressette discussed the letter of response she submitted to the Board. Bressette and Stookey answered questions from the Board.

#### Bressette and Stookey exited the Zoom meeting at 10:25 a.m.

Motion by Cook to accept explanations from Bressette and Stookey as in compliance with the law and eliminating the need for disciplinary action. Seconded by Berland. Motion passed.

Rall reviewed the Supervision Contract between Stookey and Bressette. Motion by Lewis to accept the contract. Seconded by Cook. Motion passed.

- 1) MORALES LUCIANO, Charlyn Melanie EPPP and PSE Candidate, continued. Review of Administrative Code 750-X-5-.04 Inquiries About Unlicensed Individuals. Cook noted this is not a training situation or training location. # **OLD BUSINESS:**

- Association of State and Provincial Psychology Boards' 62<sup>nd</sup> Annual Meeting of Delegates, *A New Day: No More Business as Usual*, National Harbor, Maryland, October 23 – 30, 2022. Lori Rall and Angie Ledbetter attended with Ms. Rall as the voting Delegate. Rall provided an update.
- 2) EPPP (Part 2 Skills) Virtual Town Hall Meeting Recording; Announcement from ASPPB, August 13, 2022. Discussion on updates: effective January 1, 2026, the EPPP will be one (1) exam with two (2) parts, and it will only be offered as a two-part examination. Discussion on date(s) of transition and the potential need for more meetings to plan for legislation necessary to address this change.
- 3) Military Family Jobs Opportunity Act ACT #2022-92, Passed March 8, 2022 Act requires boards to adopt related rules on or before January 1, 2023. Proposed update to Administrative Code Rule 750-X-2-.03 <u>Application Form</u>. and 750-X-2A-.03 <u>Application Form</u>., and proposed new Administrative Code Rule 750-X-2-.10 <u>Certification Of Applicants Licensed To Practice In Another Jurisdiction Pursuant To Alabama Military Family Jobs Opportunity Act</u>. Notice of Intended Action published in the <u>Alabama Administrative Monthly</u> in September 2022 and posted on the Board's website, and available as a news release. Review Public Comment(s) None received/opened as of November 4, 2022. Motion by Cook to adopt and certify the changes by publishing amended and new Administrative Code Rules pursuant to the new MFJOA. Seconded by Carlton. Motion passed.
- 4) AGIT, Maria Application to sit for the EPPP and PSE denied on January 14, 2022, for failure to meet education and training requirements; denial upheld after informal reconsideration at the May 13, 2022 meeting, which the applicant attended in person. Applicant requested a formal reconsideration that was originally scheduled for August 9, 2022 (Belle to attend), and was subsequently rescheduled for September 2, 2022 (Douglas attended). Motion by Douglas to adopt recommended Order issued by Administrative Law Judge James Jerry Wood on October 24, 2022, as written and to uphold the denial of admission to the exams pursuant to Administrative Code Rules 750-X-2-.04 and 750-X-2-.07. Seconded by Cook. Motion passed.
- 5) CHAVERS, David Joseph EPPP and PSE Candidate (Berland and Cook) Admitted to

exams on September 9, 2022. Board voted to issue an Order to candidate for failure to disclose the history of an arrest in his application materials; license, if and when issued, will be issued after candidate pays a fine of \$300.00 and with a public reprimand. Review of the Order executed on September 23, 2022 by candidate and Executive Director, Ms. Rall, who reported Dr. Chavers' prompt acceptance of the Board's decision and quick execution of the Order.
