I move that we amend the previous motion to allow this candidate to sit for EPPP and PSE, and that the previous request for clarification about employment and cautionary cease and desist communication remain in place. Once licensed, infractions may be applied to the license based upon responses to employment history and practicing without a license. Seconded by Carlton. Motion passed.

2) ZITO, Ashlee Elizabeth – Admitted to EPPP and PSE on May 13, 2022. (Cook and Carlton) Board requested either a revised specialization designation or a revised specialization statement. License issued on July 11, 2022 after successful completion of exams. Review and affirm response of more information to support Specialization in Counseling, Clinical, and Forensic Psychology. OLD BUSINESS:

 LANE, Morgan Elise – EPPP and PSE Candidate (Cook and Belle) Application tabled on May 13, 2022. Cease and desist letters were issued to the applicant and to the applicant's employer and supervisor in private practice, Dr. Felicia Houston, Ph.D. to ensure that the applicant is not practicing psychology without a license. The Board asked Dr. Houston to explain her possible role in supervising or aiding and abetting the applicant's practicing without licensure. The Board requested clarification and documentation from applicant about how the internship experience meets qualifying criteria specified in Administrative Code Rules, a professional reference from internship experience, and modification to Specialization Statement to remove planned practice in Clinical Psychology, consistent with education and training in School Psychology. Applicant was admitted to the EPPP and PSE on July 8, 2022, with potential stipulations should a license be issued (if the Board determines that she practiced without a license from December 2021 to April 2022, then the license may be issued subject to disciplinary action up to and including probation and a public or private reprimand with continuing education requirements). Review information submitted by Dr. Lane's Supervisor, Felicia Houston, Ph.D. Mr. Johnston recommended that the Board go into Executive Session to discuss the potential threat of, or possibility of, litigation, and to discuss the good name and character of an individual. Motion by Cook: I move that the Board goes into Executive Session for twenty (20) minutes to discuss the potential threat of, or possibility of, litigation, and to discuss the good name and character of an individual. Seconded by Wisely. Motion passed. The Board moved into Executive Session at 1:45 p.m. with the intention of returning at 2:15 p.m. Motion by Cook: I move that we come out of Executive Session; the time is 2:01 p.m. Seconded by Wisely. Motion passed. Motion by Cook: I move to accept the additional information provided by Dr. Lane and Dr. Houston as indicating there is no probable cause for further investigation or action related to unlicensed practice and that, in addition, Dr. Lane may continue training with Dr. Houston under the current supervision agreement as detailed in the MOU between Dr. Houston and the University of Alabama, and that Dr. Lane's license will be issued pending successful passage of EPPP and PSE. Seconded by Carlton. Motion passed. Motion by Cook: I move to notify Dr. Houston that we have determined there is no probable cause to move to move forward with action against Dr. Houston for aiding and abetting Dr. Lane's practice without licensure. Seconded by Wisely second. Motion passed.
