Review response.

Motion by Berland to continue to table the application with advisement that one's scope of practice must be commensurate with the educational training obtained in the applicant's doctoral program, which is School Psychology, and the specialization statement is still outside of that scope of practice, and to request that the applicant submit another revision describing specialization in School, only, and notify the applicant that, in the future, she may elect to exercise the option to submit a plan to enter into a doctoral program to remediate course deficiencies for specialization in Clinical as provided for in Admin Code Rule 750-X-2-.04(2)(h), and to provide a final reminder that her specialization statement must be consistent with a doctoral program in School Psychology. Seconded by Ackerson. Motion passed unanimously. Motion by Ackerson that she and Berland will review a revised statement for approval if submitted before the next meeting of the Board. Seconded by Berland. Motion passed unanimously.

2) MANIERSKI, Megan Elizabeth - (Wisely) Admitted to EPPP & PSE in November 2023, specialization in School. Board requested that candidate make a re-designation of Specialization in School Psychology only and provide a revised specialization statement to reflect future scope of practice consistent with School Psychology, and response was reviewed at January 2024 meeting. Revision was not accepted; instead, Board request more information about candidate's credentials with a doctoral degree in School Psychology and an Internship in a Counseling setting but not in School Psychology emphasizing the application of psychological principles and skill to learning problems, meeting qualifying criteria outlined in Rule 750-X-2-.07, and request an explanation about how qualifying coursework and internship training meet Administrative Code Rule 750-X-2-.06(1) and -(2)(d), and -(2)(d)(viii), specifically. Review response. Motion by Berland to continue to table the application with advisement that one's scope of practice must be commensurate with educational training obtained in the applicant's doctoral program, which is School Psychology and the specialization statement is still outside of that scope of practice, and to request that the applicant submit a revision once again describing specialization in School, only, and notify the applicant that, in the future, she may elect to exercise the option to submit a plan to enter into a doctoral

program to remediate course deficiencies for specialization in another area as provided for in Admin Code Rule 750-X-2-.04(2)(h), and to provide a final reminder that her specialization statement must be consistent with a doctoral program in School Psychology, and that Berland and Ackerson will review a revised statement for approval if submitted before the next Board meeting. Seconded by Ackerson. Motion passed unanimously.

- ASPPB Mid-Year Meeting April 25 to 28, 2024, Boston, MA. Rall and Han, and others, to attend. Board Administrators/Registrars Committee (BARC) Meeting on Wednesday, April 24; Rall is Chair-Elect.
- 2) Alabama Department of Examiners of Public Accounts' Resource Manual for Alabama Regulatory Boards and Commissions, Twentieth Edition, August 2023 Available now at https://alison.legislature.state.al.us/epa-resource-guide; also provided in Dropbox. Reminder.
- 3) Alabama Psychological Association (aPA) Mid-Winter Conference: Minds in Action: Advancing Psychology Through Advocacy and EDI – February 15 & 16, 2024, Legacy Museum at Equal Justice Initiative, Montgomery, AL. Rall attended. Update. Review by Rall. There will another aPA meeting in Birmingham on April 7, 2024 at 5:00 p.m. Lori will send a calendar invitation to Board members once details are announced.

NEW BUSINESS:

- 2) Senate Bill 79, Sponsored by Senator Rodger M. Smitherman: Occupational Licensing Boards, consideration of criminal conviction when licensing restricted, requiring an occupational licensing board to determine whether an individual's criminal conviction disqualifies them from obtaining an occupational license in certain circumstances. Review. Cook questioned how this might impact how licensure for professional practice is issued versus occupational licensure. For a fee of \$20.00, an individual would receive a pre-certification for work after committing a crime. Rall advised that this type of pre-licensure review and certification exists in many other states already. Han added that this would be another section for consideration in meeting agendas. Rall advised the Board to consider how it would like to respond to this bill as it currently already requests full disclosure and honesty when vetting an individual. Motion by Cook for Rall to draft a letter to Senator Smitherman opposing the inclusion of the Alabama Board of Examiners in Psychology from any such bill, explaining the difference between occupational and professional, and emphasizing the Psychology Board's strong commitment to reduce barriers to licensure. Seconded by Lewis. Motion passed unanimously.
- 3) House Bill 246, Sponsored by Representative Ben Harrison: Consent to medical treatment; age of medical majority, established at 18 up from age 14, currently; circumstances in which a

minor may receive medical treatment, revised. Review. Motion passed unanimously. Rall advised that, if passed, the Bill would create a conflict of law that the Board would potentially need to address by introducing legislation to provide a definition for the age of consent in the Board's statutes instead. Motion by Ackerson for Rall to draft a letter to Representative Harrison and the Health Committee explaining the Board's disagreement with this bill and potential consequences, particularly for children who might need mental health counseling, compromising the quality of psychological services, and to note the Johnson Ruling in the letter. Seconded by Cook. Motion passed unanimously.

- 4) Thentia Cloud Licensing and data solutions via Carahsoft Contract. Presentation. Motion by Wisely for Rall to exercise her judgement to make a decision about the Board office implementing Thentia Cloud as a database, communications platform, and records repository, and when. Seconded by Carlton. Motion passed unanimously.
- 5) Quarterly Reporting Fourth Quarter 2023. Review by Rall.
- 6) PSYPACT Fourth Quarter 2023 Compliance Report. Rall advised Alabama is compliant in every way. Rall fielded questions about practice under PSYPACT from Berland.
- 7) ASPPB Governance Update: Virtual Town Hall, March 25, 2024 at 1:30-3:00pm EDT. Invitation to register. Ackerson, Berland, and Rall plan to attend.
- 8) APA Master's Accreditation Virtual Town Hall Recording. Rall advised the recording is in Dropbox and urged Board members to review it.
