OLD BUSINESS:

- ASPPB Mid-Year Meeting April 25 to 28, 2024, Boston, MA. Rall, Han, and Ackerson attended. Board Administrators/Registrars Committee (BARC) Meeting took place on Wednesday, April 24; Rall is Chair-Elect. Regular meeting began on Thursday, April 25. Update of meeting highlights by Ackerson, Han and Rall.
 - a. EPPP2 The Examination for Professional Practice in Psychology will become one exam in two (2) parts as of January 2026. Discussion. Recommendation by Cook to wait until closer to that date; Rall will place topic on the agenda again within the year.
 - b. Visit from ASPPB representatives. Rall will invite Alex Siegel, J.D., Ph.D. and Hao Song, Ph.D. to attend a meeting of the Board in person as soon as their schedules will allow, or via Zoom.

Dr. Terrell left the meeting at 12:46 p.m.

- 2) Alabama Department of Examiners of Public Accounts' Resource Manual for Alabama Regulatory Boards and Commissions, Twentieth Edition, August 2023 is available at <u>https://alison.legislature.state.al.us/epa-resource-guide</u>; also provided in Dropbox. Rall thanked Board Members and Staff for completing required Examiners of Public Accounts Board/Commission Training for 2023-2024 by May 1, 2024, and stated she provided confirmation of the agency's compliance to Dixie Broadwater Thomas, Director of the Operational Audit Division of the Examiners of Public Accounts.
- 3) Statements of Economic Interests have been submitted to the Alabama Ethics Commission, as might be required annually of Board Members and Administrative Staff. Rall thanked Board Members and Han for submitting required annual reporting.
- 4) Senate Bill 79, Sponsored by Senator Rodger M. Smitherman: Occupational Licensing Boards, consideration of criminal conviction when licensing restricted, requiring an occupational licensing board to determine whether an individual's criminal conviction disqualifies them from obtaining an occupational license in certain circumstances. Rall informed the Board that letters were sent to Senators Smitherman, Orr, Singleton, and Stewart detailing the Board's position on the matter.
- 5) House Bill 246, Sponsored by Representative Ben Harrison: Consent to medical treatment; age of medical majority, established at 18 up from age 14, currently; circumstances in which a

minor may receive medical treatment, revised. Rall informed the Board that the Bill did not progress after introduction and assignment to the House Health Committee.

NEW BUSINESS:

- 1) Board Newsletter More information needed from outgoing Chair (Cook) and the Alabama Psychological Association. Ackerson to submit statement about neuropsychological practice.
- 2) Act 2024-157 Continuing the existence and functioning of the Alabama Board of Examiners in Psychology until October 1, 2028, introduced as HB144, Sponsored by Senator Coleman-Madison.
- 3) Senate Bill 224 introduced on March 19, 2024, Sponsored by Senator Chis Elliott: Establishment of the Office of Occupational and Professional Licensing within the Department of Labor to serve as a centralized entity to certain professional licensing boards, including the Psychology Board as of October 1, 2026, but amended to not include the Psychology Board. Rall provided a status update – Currently Indefinitely Postponed as of 05/07/2024 – and thanked the Board for its guidance, effort, responsiveness, and support throughout the Legislative Session.
- 4) PSYPACT Updates:
 - a. Board reviewed the PSYPACT Commission's First Quarter 2024 Compliance Report confirming Alabama's compliance in all areas. The Board thanked Rall for the work and the update.
 - b. The Board reviewed the Commission Newsletter, March 2024.
- 5) Rall presented Quarterly Reporting to the Board for the First and Second Quarters of Fiscal Year 2024.
- 6) Alabama Psychological Association, 2024 Annual Convention, August 23–25, 2024, Hampton Inn and Suites, Orange Beach, Alabama. Rall has been invited to attend the conference as a presenter. Motion by Cook for Rall to provide an update to the Alabama Psychological Association at their convention in August 2024. Seconded by Carlton. Motion passed unanimously.

End of Meeting: Motion by Carlton to adjourn the meeting. Seconded by Cook. Motion passed unanimously. Meeting ended at 1:26 p.m.
