  - a. 39<sup>th</sup> Mid-Year Meeting, April 23 27, 2025 Montreal, QC, Canada. Registration is open. Rall is Vice Chair / Chair-elect of BARC and will present on the topic of Consolidated Boards on Friday, April 25; therefore, some travel costs will be covered by ASPPB. - 2) Property Audit by the State Auditor of Alabama was conducted on February 12, 2025. Ledbetter serves as the Board's Property Manager. Audit results letter received, review.
- 3) School Psychologist Interstate Licensure Compact introduced in Legislative Session 2025 as SB61 and HB214 Signed by Governor Kay Ivey on April 9, 2025, **Act Number 2025-207**. Update by Han and Ledbetter. With implementation of this compact, Cook expressed concern to have a School Psychologist serve on the Board; may need to be fixed through modifications to the law.
- 4) Alabama Legislative Session, 2025 Proposed legislation with significant potential:
  - a. SB39, requiring Board Members to complete training, meet attendance standards. Update by Carlton.
  - b. SB138, addressing the issuance of occupational licenses for convicted felons. Update Han and Ledbetter.
  - c. HB267, SB58, and SB101, regarding changing the age of consent for mental health services from 14 years to 18 years, with some exceptions, and a minor's confidentiality. Update by Ledbetter and Wisely.
